Thanks to the broad scope of psychological research and their close collaboration with other professionals in schools, businesses, communities, and health care institutions, psychologists are in a unique position to contribute to the improvement of physical and mental health in Europe.

The aim of this conference is to highlight findings from psychological research and to demonstrate how psychologists can add to the work of other experts in safeguarding and promoting the health of European citizens. A particular emphasis is put on the role that psychology can play in developing healthy life styles, the early discovery of health risks, and various forms of prevention.

This conference will bring together experts from various areas of psychology, offering different but complementary perspectives on promoting health and reducing illness, with the purpose of sharing insights and experiences with policy makers and formulating policy statements as well as recommendations for future policies at the European and national level.

We expect 250 participants, including key actors from European institutions and EU Member States, the health sector, and NGOs, particularly those involved in the EU's Health Programme.

The conference is part of the “Psychology for Europe” initiative (2011) by which the European Federation of Psychologists Associations aims to raise the visibility and impact of psychology as a broad and potent field of science and professional activity that can bring substantial benefit to Europe, socially and economically.



Areas of expertise that will be covered

1. Health promotion via behaviour change: life style, addiction and health
2. Life-long learning and health: what school psychologists can do
3. Enhancing the prevention and early treatment of mental ill-health: depression and suicide
4. Employment, working conditions and stress: from research to practice
5. Managing serious illness: focus on patients and care-givers
6. Health inequality in times of crisis: alleviating the impact of unemployment and poverty
7. Health improvement through physical activity: lessons from sport psychology
8. Psychological contributions to healthy ageing and longevity

The programme will also provide room to address other health issues, such as the behavioural immune system, medically unexplained symptoms, and social violence.

- be a chance to debate the future action needed at EU level to reduce the burden of the disease
- be the official launch of the European COPD Coalition (ECC)

The event will bring together health professionals, patient groups, health promotion organisations, European and national public authorities dealing with health, as well as life science firms. There will be speakers from the European Commission, Members of the European Parliament, ECC representatives and patients suffering from COPD. The meeting will be an opportunity to hold a wide-ranging debate with the speakers and participants on the challenges of COPD in Europe today.

Up to 10% of the European population suffers from Chronic Obstructive Pulmonary Disease (COPD) in Europe, most of them do not know they have it and an increasing number die from the disease - yet the condition is generally unknown. COPD is a major chronic, debilitating and costly respiratory disease that, if not addressed properly, will be the 3rd cause of death worldwide by 2030, according to the World Health Organization (WHO). However, until now, COPD has not gained sufficient attention from European policy makers.

**Seminar: Internationalisation audits, Assessing and Improving Institutional Strategies

This seminar intends to contribute to the enhancement of quality internationalisation in Europe and beyond. Participants will be in a position to identify their "ideal" tool for quality improvement from amongst the instruments available - or, indeed, to construct their own self-assessment methodology. Leading specialists from the field will be present, as Neil Kemp, of the Institute of Education of the University of London, Rolf Peter of the German Rectors' Conference (HRK), and Will Archer of i-graduate. The opening speech will be given by Eva Egron-Polak, the Secretary General of the International Association of Universities (IAU), one of the world's leading experts on internationalization.



Europe's universities have become much more international in the past decades. But the business of internationalising higher education is by no means 'finished'; indeed, much remains to be done. Internationalisation must now improve in quality and it needs to become 'made-to-measure' to serve different institutional aims and objectives. It must also be adapted to the new 'multipolar' higher education world order, in which Western universities and colleges continue to play an important, but not any longer an exclusive role.

In reaction to this need, a wide range of 'internationalisation audits' have been developed in recent years. These instruments are all devoted to the evaluation and the improvement of institutional strategies for internationalisation. The aim of this seminar is to present the most important and relevant of these, and to analyse their respective merits - and possible downsides. Most of the audit tools presented are based on external review, but some are self-evaluation and self-assessment exercises. While some of them have been developed for use across the globe (or an entire continent), others target the institutions of one single country. Some take a comparative approach, i.e. they engage in mutual benchmarking, while others are strictly non-normative and measure institutions exclusively against their self-set aims and aspirations.

As the internationalisation ambitions of higher education institutions throughout the world have expanded in recent years so, too, has the need to effectively track and measure the impact of internationalisation efforts at the institutional level. One of the most recent resources developed to this end in the European context is the IMPI toolbox, which has been elaborated in the framework of a soon-to-be-completed project, Indicators for Mapping and Profiling Internationalisation <http://www.impi-project.eu/>.



This assortment of indicators (the toolbox) is meant to provide higher education institutions with insight into their performance in internationalisation as well as ideas on how to improve their performance in this area in the future. The toolbox is geared towards two principal uses - institutional self-assessment and international/inter-institutional benchmarking. The IMPI toolbox was co-developed by six European organisations in the field - CHE Consult, ACA, CampusFrance, Nuffic, Perspektywy and SIU - in cooperation with over 40 European higher education institutions. 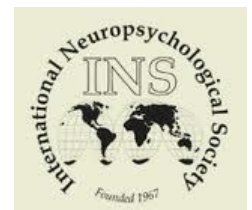

Baseline Report on Sustainable Lifestyles published

Because of the significance of housing, transport, food, health and society, the report focuses on these key domains. It aims to better understand the relationships between lifestyles, the conditions that frame those lifestyles, and the resulting sustainability impacts in Europe today and into the future.

In addition, it identifies promising practices from across Europe that have the potential to be examples of sustainable ways of living of the future. Existing visions, scenarios and roadmaps for more sustainable futures – from policy, research, business and civil society perspectives – are also examined in detail. This final version of the baseline report builds upon an earlier draft version prepared for the launch conference of the SPREAD Sustainable Lifestyles 2050 project, which took place in May 2011. EFPA or its member associations could become a promoter within the framework of this program and thus eligible for funding:

Eligible promoters Youth in Action projects are submitted and, if selected, managed by promoters representing the participants.

Are you:
-a non-profit or non-governmental organisation
-a local, regional public body
-an informal group of young people

- a body active at European level in the youth field (ENGO), having member branches in at least 8 Programme Countries
- an international governmental non-profit organisation
- a profit-making organisation organising an event in the area of youth, sport or culture legally established in one of the Programme or Partner Countries?

If so, you can be promoter of a Youth in Action project depending on the Action and sub-Action concerned. For the conditions for participation in specific Actions or sub-Actions, please consult Part B of this Guide. If your project is selected, you become a "beneficiary" of the Programme. A beneficiary is a promoter who will be proposed a grant agreement for the realisation of the project (grant agreements are not proposed to the participants themselves). What is a body active at European level in the youth field? A body active at European level in the youth field is a European Non Governmental Organisation which pursues a goal of general European interest and whose activities are aimed at young people's participation in public life and in society and the development of European cooperation activities in the youth field.

An ENGO must:

- be legally established for at least one year
- be non-profit-making
- be established in one of the Programme Countries, one of the countries of the Western Balkan, in Belarus, Moldova, Russian Federation or Ukraine
- operate at European level
- be active in the field of youth (it may be a body whose activities are solely for the benefit of young people or a body with wider aims, some of the activities of which are for the benefit of young people)
- have a structure and activities covering at least eight Programme Countries (it may be a European network representing bodies active in the field of youth)
- run activities in accordance with the principles underlying the Community activity in the youth field
- involve the young people in managing the activities conducted for their benefit.

For the purpose of applications to be submitted under the permanent actions of the Programme Guide, beneficiaries under sub-action 4.1 will be automatically considered as bodies active at European level in the youth field.

The measure "Citizens projects" aims at exploring innovative methodologies and approaches to encourage citizens' active participation at European level and to stimulate the dialogue between European citizens and European institutions. Under this measure a variety of projects of a transnational and cross-sectoral dimension, directly involving citizens will be supported. Priority is given to projects aimed at encouraging local level participation. Eligible: Civil society organisations (CSOs) include among others, trade unions, educational institutions and organisations active in the field of voluntary work and amateur sport (e.g. NGOs, umbrella

organisations, networks, associations and federations, think tanks, universities, religious organisations).

Citizens' projects are expected to:

Collect the opinion of citizens on some key European challenges for the future;
Explore new methodologies capable of promoting active interaction and discussion between citizens on matters related to EU policies that affect their daily life;
Create mechanisms that allow European citizens to develop civic competences, to formulate their views and opinions on the European integration process in the form of recommendations for policy makers at European level;
Encourage the dialogue between European citizens and the institutions of the EU, empowering citizens as regards EU policies and their impact, and ensuring appropriate follow up of citizens' opinions by the EU institutions.

In this regard it is requested that at least 30% of the participants of the project must come from countries other than the country that hosts the project event.

Support Measures aim at supporting the activities which may lead to the establishment of long-lasting partnerships and networks reaching a significant number of different stakeholders promoting active Europe citizenship, thus contributing to provide a better response to the programmes' objectives and maximizing the overall programme impact and effectiveness. Support measures are expected to finance activities implemented by the structures such as platforms and networks targeting to develop and strengthen all programme's actions thus contributing to smooth programme implementation and assuring the large transnational coverage in favor of potential programme's stakeholders by means of the following types of activities: Training sessions enabling the potential Europe for Citizens

Europe for Citizens Programme Information sessions promoting the Europe for Citizens Programme or its specific measure and targeting exchanges of experience and best practices among the current and potential programme's stakeholders; Creating platforms facilitating partner search and networking among current and potential stakeholders.

each. Their authors will present their works in a conference to be organised in December 2012; the articles will form part of a publication disseminated widely in Belgium and Europe via the European Network of the Foundations for Social Economy.

It also requires the corresponding budget to be approved at European and national levels so that activities such as European, national and local-level awareness-raising campaigns and proposals for political initiatives (a new European programme, new legislation, new political objectives etc) can be funded.
